LEARNING FROM EXPERIENCES

Our LTTA in Tarragona

During the week of 19-23 of June, partners reunited in Tarragona for a **whole week of learning and sharing experiences and knowledge**. The Universitat Rovira i Virgili (URV) organised a series of lectures and round tables that were of great value to the project.

We kicked off our Learning, Teaching, Training Activity (LTTA) with an inspiring lineup of presentations. The introduction session was led by Marco Aurelio Navarro Roux and Aimée Stuflesser, from AIS, by providing an outline of the project and a comprehensive overview of the different aspects and the current situation of migrants and refugees in Europe, especially of those from Latin America and the Caribbean.

Over the days, we could count on the expertise of **different experts in the field**. We had insightful and though-provoking presentations:

- Claudia Anleu, social work profesor from the University, presented "Latin Americans moving forward", which shed light on the topic of resilience
- Angel Belzunegui Eraso, a Sociology professor and former Director of the URV's, presented "The foreign population in Spain at the core of social vulnerability" which delved into the experiences of the foreign population in Spain and their intersection with social vulnerability.

- Adding to the insightful discussions, Raquel Martinez Buján, a distinguished sociology professor from the Universidad de A Coruña, shared her expertise on "Care workers in the digital economy: new precarity for migrant women".
- Ruben Lasheras, a Sociology Professor from Universidad Publica de Navarra, shared his expertise on "Risks in immigrant integration policies".
- Albert Marti, a Law Professor at URV, provided valuable insights into the legal aspects of emigration in his presentation "Emigration from the legal point of view".

Also, our LTTA held two round tables to discuss the role of the public Administratoins and NGOs in the social inclusion of migrant and refugees. To discuss this issue, we had several guest speakers:
